## **GENERAL RELEASE AND ACCEPTANCE OF RULES**

The 2021 Holy Trinity Bazaar and Artisan Market will follow all CDC and local restrictions in place at that time with respect to the pandemic and we will implement all indoor and outdoor precautions recommended, including any masking requirements or limited indoor capacity. In addition to utilizing our new outside Green Space, we are expanding the building space utilized for the event this year to include both levels of our parish hall to allow much more spacing between booths and adequate ventilation.

Pending cancellation of the event due to CDC restrictions, our registration fee is non-returnable and non-refundable, even if you decide not to do the show for some reason. All efforts will be made to place you in the booth of your choice, but the promoters reserve the right to substitute space should your first choice not be available.

An indoor booth provides 2 chairs and an 8' table. Payment for an indoor booth must be received along with the application. All applications need to be received by September 15, 2021.

Artists requesting an outdoor booth will need to provide their own equipment. Outdoor booths will be located in the 115 ft by 62 ft Green Space beside the church buildings. Small tents are allowed (typical tailgating tents 10' x 10'), but we ask that you do not "stake" them to the ground to help preserve the lawn. Payment for outdoor booths will be collected the day of the event (in case of rain). Power is not provided to outside artists. Applications will need to be turned in by September 15, 2021.

Receipt of this agreement does not guarantee the Artisan a spot in the Gift Market. The ECW reserves the right to accept or decline registrations based on availability, content and other criteria which the ECW feels appropriate for the Artisan Market. All decisions by the ECW are final. We suggest you keep a copy of these forms, as well as any future communication with ECW, for your records. In addition, I/we, the applicant(s), do expressly release the Episcopal Church Women (ECW), Holy Trinity Episcopal Parish (HTEP), all employees, representatives, and volunteers acting on behalf of ECW and HTEP from any and all liability for any damage, injury or loss to any person, business or property which may arise from the licensing and occupation of the exhibit space by the applicant(s), and agree to hold and save ECW, HTEP, and all employees and representatives acting on behalf of ECW and HTEP harmless of any damage, injury or loss by reason thereof.

If this licensing application is accepted, I/we give permission to use my name, business name, slide/image descriptions, item prices, slides/images and any photographs, videotape, or images of me or my items for any and all purposes. All Artisans are responsible for complete clean up of their area, bringing all garbage and refuse with them.

## **CONDITIONS OF THE SHOW**

1. The Artist or Craftsperson who designs the work and is a principal of the business MUST be present to sell his/her work. If the craft or art is signed by an individual, he/she must be at the show. If the business is named after the artist, that individual must be at the show in person.
2. No dealers or sales representatives are allowed.
3. All work must be original and completely finished. No imports, kits, items made from kits, items made using commercial patterns or commercial molds, items assembled from pre-manufactured components, unfinished work, items made from elephant or whale ivory, embellished items, commercial T-Shirts, commercial Sweats, or art and craft supplies may be displayed or sold.

4. An application is a commitment to the show. No refunds will be given after the acceptance notice is sent unless event is cancelled due to CDC or local restrictions.
5. ECW reserves the right to revoke the license granted by this contract at any time, including at the show, by refunding the space fees paid by the Artisan. ECW will not be liable for paying any travel expenses, parking, lost revenue or any other liability whatsoever beyond the space fees paid by the Artisan as a result of enforcing this provision.
6. The Artisan's display must be staffed during all regular show hours. Do not begin breaking down until after 2:00 p.m.
7. All exhibits, goods and materials must be removed from the church parish hall by 4PM on Saturday, October 16, 2021.
8. Artisans must abide by all fire regulations and decisions of the representatives of local fire departments.
9. Nothing shall be nailed, stapled or otherwise fixed to the walls, floors or any part of the exhibition rooms.
10. All exhibits are to be in keeping with the overall theme of the show.
11. Artisans are not to bring pets to the show.
12. All Artisans are responsible for keeping their areas clean during show hours, including clean-up at the end of the show. All displays should be neat and clean and tables should be covered on all sides to the floor with a suitable, professional looking cover of flame retardant materials.
13. Artisans and their helpers must exhibit professional behavior at all times while at the show. ECW reserves the right, in its sole discretion, to determine what constitutes professional behavior. Violation of this rule will result in the Artisan, their helpers and exhibits being excluded from the show with no refund or allowance whatsoever. In addition, Artisans violating this rule may be removed from future ECW shows with no refunds.
14. All extension cords used at the show must be the heavy-duty, three wire type. No two wire extension cords are allowed. Extension cords may only used with permission of HTEP. If you require electricity, please advise with the application so a booth can be provided near a plug.
15. Artisans may not sublet or apportion space to anyone else.
16. No open flames are permitted.
17. There cannot be any kind of taping done to the floor unless painter's tape is used. Masking tape and duct tape are not allowed on the floor.
18. ECW will not be liable for refunds or any other liabilities whatsoever for the failure to fulfill this contract due to reasons of the enclosure in which the show is to be produced, being, before, or during the show destroyed by fire or other calamity, or by any act of God, public enemy, strikes, statutes, ordinances, or any legal authority, or any cause beyond its control.
19. Insurance, if desired by the Artisans, must be obtained by them at their own cost.
20. Artisans shall be liable for delivery, handling, erection, and removal of their own displays and materials.
21. Artisans found in violation of any of the "Conditions of the Show" may be excluded and have their exhibits removed from the current and/or future shows at the sole discretion of ECW. In such cases, no refunds will be issued. Under no circumstances, including negligence, shall ECW or HTEP be liable for any direct, indirect, incidental, special or consequential damages resulting from such action.
22. The ECW may require the removal of work considered to be in violation of these conditions and reserves the right to make final interpretation of all conditions.
23. If any section, sentence, clause, phrase or portion of this licensing application/contract is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions.

24. This contract constitutes the entire agreement between the ECW and the Artisan and no modification shall be valid unless in writing and signed by the parties or their representatives.
