# Vestry Meeting 3/20/2022 (Hybrid Meeting: In-person and Zoom)

**<u>ATTENDING</u>**: Mtr. Suz (Rector), Ellen Haase (Senior Warden), Clem Watson (Junior Warden), Jan Cribb, Jen Ellison, Betty Snowden, Mary Lou Sigsby, John Warner, Harry Morse, Mark Stokes, Lynn Luszcz, Mel Harriss, and Jean Ellen Zavertnik.

ABSENT: Jack Mckenna (Treasurer), Jen Ellison, Rev. Noah Stansbury

Mtr. Suz Opened the meeting in prayer. She led an exercise in listening and sharing thoughts about a passage of scripture and its implications for the Vestry.

# OLD BUSINESS

Harry Morse made a motion to approve the February 2022 Vestry minutes; seconded by Mary Lou Sigsby. Motion passed unanimously.

2022 Holy Trinity Parochial Report was approved unanimously by email vote prior to the Vestry meeting.

# NEW BUSINESS

Treasurer's Report – See **ATTACHMENT A** for a summary of the Treasurer's Report. Points discussed during the meeting include:

- Cash decreased because of mortgage payments.
- Plate and other offerings have increased, likely because more people are coming back to church. We also are seeing new people attending. Pledge offerings are slightly over budget for the month.
- Our budget deficit is lower than the deficit projected in the budget.
- We hope to see parking revenue come in in March football and merchants.
- "The Doors" campaign pledge payments are slightly down. Reminders should get those gifts back on track.
- YTD we have \$75,000 in gifts to Trinity place

Betty Snowden made a motion to approve the Treasurer's Report; seconded by Jan Cribb. Motion approved unanimously.

Finance Committee Recommendations (Also in ATTACHMENT A)

- The Finance Committee put forward a recommendation/motion to apply a recent gift of \$5,000 for Trinity Place to the Demolition Loan. We hope to pay off the demolition loan by the end of this year. Clem Watson seconded the recommendation of the Finance Committee. Motion passed unanimously.
- The Finance Committee put forward a recommendation/motion regarding the reporting of the expenditure of church funds that are outside the regular operating budget. Since the Vestry has

a fiduciary responsibility for all funds from Holy Trinity, it follows sound accounting practices and checks/balances to approve all expenditures. Examples include funds raised for special purposes, such as proceeds from the ECW Bazaar that are distributed to charities. After some discussion, it was determined that we need to talk to those impacted by this change before voting. As such, the matter is tabled. Mtr. Suz will speak with Diane Manley and Ellen Haase will speak with Cindy Thakham. Both will report back to the Vestry at the next meeting.

**Outreach Budget for 2022 – See ATTACHMENT B:** Harry Morse discussed the proposed outreach budget. He said Rachel Mayo and Rachel Rowe are doing an excellent job leading the Outreach Committee. The Vestry voted to approve the proposed budget.

**Endowment Committee – See ATTACHMENT C.** A proposal was set forth by the Finance Committee to approve changes to the Endowment Committee policies to eliminate term limits. This committee reports to the Finance Committee and oversees investments we have within the Episcopal Church Endowment. John Warner seconded the recommended change by the Finance Committee. Motion passed unanimously. We need to appoint two new Endowment Committee members. Ellen is going to reach out to two potential committee members and report back to Vestry to formally appoint them.

**St. Paul's Committee:** The chair, Eric Naeseth, is stepping down. There is a proposal to appoint Mary Lou Sigsby as interim chair. Clem Watson made a motion to approve Mary Lou as the new chair; seconded by Jan Cribb. Motion passed unanimously.

**EDS Cookout:** The Fellowship / Engagement Ministry will host an Episcopal Day School (EDS) Cookout on Monday, May 2, 2022. Normally the event is a spaghetti supper that Vestry helps with each year. However, this year the Day School board wants a cookout at Trinity Place. The Vestry needs to help set up, cook, and clean up. At our April Meeting, Jan Cribb will have a sign up sheet.

**Vestry ReNewal Retreat:** The retreat is scheduled for Friday, March 25, from 6 to 9 PM and Saturday, March 26, from 9 AM to 12:30 PM via Zoom.

# **REPORTS**

#### **Holy Trinity Balance Sheet**

- 1. The checking account balance shows a significant decrease because the two gifts (totaling \$70,000) have now been applied to the demolition mortgage.
- Nothing else in the assets have changed except 0.04 interest in the MMKT account-making additional explanation unnecessary.
- The demolition mortgage has decreased by \$72,327.36, which is the \$70,000 in gifts plus the regular monthly mortgage payment.
- 4. The construction mortgage also decreased by \$10,146.05. Down is always good!
- 5. The fund balances show small changes—some up and some down.
  - a. The St. Paul's Thrift Shop allocated some funds.
  - b. The Diocese has reimbursed Holy Trinity for some Canterbury Club expenses so the balance is no longer negative.
  - c. There was a decrease in the Youth Fund for the upcoming trip.
  - d. There was a \$2,000 donation to the Endowment Fund.
- 6. The overall financial position of Holy Trinity Funds increased by \$5,028.97 in February.

#### Holy Trinity SOM

- 1. Plate and Other Offerings are substantially over budget. Hopefully, this trend will continue as inperson attendance at church services increases. YTD is \$2,504.13 over budget.
- 2. Pledge Offerings are slightly over budget for the month but still \$1,989.21 below budget YTD.
- Salary and Benefits expenses were slightly above budget. However, YTD, we are only \$208.49 over budget out of a budget of \$59,950.00, which corresponds to 0.35% over budget.
- 4. Diocesan Assessment is on track.
- Clergy Discretionary funds show no activity. This is a result of Lynne not having access to Church Windows for more than a week. The bank statements do show some activity in February for the Discretionary accounts.
- 6. No funds were expended for Outreach in February.
- Facilities expenses appear over budget because the Property and Liability Insurance is paid quarterly but they are tracking with budget projections and will come back in line next month.
- Utilities were slightly over budget for February but \$97.67 under budget YTD.
   Very little was spent in February for Mission and Program Expenses (only 55% of budgeted). As
- very little was spent in February for Mission and Program Expenses (only 55% of budgeted). As COVID-19 restrictions are eased, more spending will be expected.
- Mission/Program Support expenses are \$1,460.38 under budget YTD although some are over budget because they are not regular monthly expenses. The good news is that Printing and Publications is \$1,115.44 under budget YTD.
- 11. Income minus expenses for February shows a deficit of \$1,769.02 for the month. However, YTD income minus expenses is \$5,463.89 to the good.

#### **Trinity Place Budget**

- 1. Football parking has yet to begin coming in so it looks like we are way below budget YTD. This will hopefully self-correct as football parking begins to come in later in the year.
- 2. With the approval the parking policies and procedures by the Vestry at the February meeting, bills for merchant parking can be sent and parking revenue will soon begin to be received. This will help the balance sheet a lot!
- OUR DOORS Pledge Offerings have fallen off again in February. A number of people have normally paid their pledges for the year in January and February so this drop-off is a bit concerning. If this continues in March and April, we may have to delay the \$5,000 in additional principal payments.
- 4. There is some very good news! A \$5,000 gift was received to be directed towards Trinity Place. We have some very generous parishioners!
- 5. On February 28, 2022, the Trinity Place Fund Balance is \$33,328.18.

At the Finance Committee meeting on March 8, 2022, the Finance Committee voted to authorize up to \$3,000 to have Pye-Barker Fire and Safety replace the fire control box in the office complex. This is close to half of what Johnson Controls charged us to replace the fire control box in the Parish Hall. Additionally, Pye-Barker Fire and Safety will now be conducting the annual fire inspections (again at a cost about half of what Johnson Controls had been charging). This change will result in substantial annual savings. Thanks to Lynne Farmer and Clem Watson for their diligence!

#### Ellen.

Lynne reported receipt of an anonymous gift of \$5,000 for Trinity Place. Bob Taylor provided an analysis of the financial impact of applying the \$5,000 to demolition loan in March as an early principal payment in addition to the \$5,000 early principal payment already planned. This action will save \$97.18 and pay off the demolition loan one month earlier (October 2022) instead of November 2022). A second option is to hold on to the money and apply it to the construction mortgage after the demolition loan has been paid off. Bob's analysis of the financial impact shows that there will be enough in Trinity Place funds for either option.

The Finance Committee voted to recommend the option of using the \$5,000 gift as an additional principal payment to the demolition mortgage in March, resulting in the demolition being paid off one month earlier and saving an additional \$97.18 in interest.

Mtr. Suz pointed out a potential issue with our current Expenditure Policy. As currently written, the policy only applies to "Expenditures from Holy Trinity budgeted monies." As a result, any group that raised money on their own is technically not subject to the Expenditure Policy. As a result, Mtr. Suz was uncomfortable authorizing the expenses from the ECW because they are not reviewed by the Vestry or the Finance Committee. The issue is clearly not one of whether or not the proposed distributions are appropriate but rather one of process because whether or not the funds are budgeted, the Vestry has a fiduciary responsibility for all funds from Holy Trinity.

As a result, the Finance Committee voted to recommend to the Vestry that all committees or groups report proposed expenditures of non-budgeted funds to the Vestry prior to disbursing the funds so that there can be a coordination of efforts, avoidance duplication of efforts and provide communication of activities. This motion essentially sidesteps the issue of the approval of non budgeted disbursements in favor of reporting prior to disbursing funds. In this way, the Vestry could decide some expenditure was deemed inappropriate and vote to not approve the expenditure. A second option would be to extend the Expenditure Policy to apply to the disbursement of all funds whether budgeted or not.

This will require Vestry action.

# Proposed change to the Endowment Fund Board Plan of Operation

20 March 2022

## Proposal:

The Endowment Board proposes an amendment to the Endowment Fund Board Plan of Operation to delete "No member shall serve more than three consecutive three (3) year terms. After a lapse of one (1) year, former BOARD members may be re-elected." See the full text below.

## Rationale for the request is as follows:

Permitting members to serve for longer periods provides more continuity and lessens the need to regularly recruit new members. For those willing to serve, the work of the Board requires minimal time commitment for two main reasons:

a) the long standing position of the Vestry to not make disbursements until such time that the Fund assets are significantly larger (currently \$128,000) and

b) the assets are held in two mutual funds offered through the national church, thus requiring no active management participation by the Board. [The Board regularly reviews fund performance.]

The Vestry would still retain discretion on Board membership as the appointer of Endowment Fund Board members. So, at the end of a member's term, the Vestry may decide to appoint someone new.

## **Current Endowment Fund Board**

The current Endowment Fund Board with terms is as follows:

- Ron McGimpsey Completed his second 3-year term in 2020. Ron is serving his third term that would end 2023.
- Isabel Candela Completed her second 3-year term 2020. Isabel is serving her third term that would end 2023.
- Nigel Kaye New term began 2019 and ended 2021. Nigel's second three-year term ends at the end of 2024.
- 2 vacant board seats the Vestry needs to appoint replacements for these.

## **Original ENDOWMENT FUND BOARD PLAN OF OPERATION**

## 1. The BOARD

The BOARD shall consist of five members, all of whom shall be members in good standing of Holy Trinity Episcopal Parish; they shall be appointed by the Vestry. Additionally, the Rector and Senior Warden shall be *ex-officio* members of the BOARD. Except as herein limited, the term of each member shall be three (3) years. Upon adoption of this resolution, two (2) members shall be appointed for a term of three (3) years; two (2) members for a term of two (2) years, and one (1) member for a term of one (1) year. Thereafter, on an annual basis, the Vestry shall appoint the necessary number for a term of three years. No member shall serve more than three consecutive three (3) year terms. After a lapse of one (1) year, former BOARD members may be re-elected. In the event of a vacancy on the BOARD the Vestry shall appoint a member to complete the unfulfilled term, upon the completion of which that person would be eligible for re-appointment to a normal three (3) year term.

- Stewardship Campaign kicked-off October 10th with the in-gathering on November 14th.

- Below is a summary of our campaign results to date.

November 30 - 96 Pledge Cards, \$442,616 pledged, \$4610.58 average pledge December 14 -105 Pledge Cards, \$456,404 pledged, \$4346.70 average pledge December 21 - 112 Pledge Cards, \$477,524 pledged, \$4263.07 average pledge January 3 - 114 Pledge Cards, \$480,524 pledged, \$4215.12 average pledge February 3 - 119 Pledge Cards, \$488,044 pledged, \$4031.39 average pledge March 3 - 119 Pledge Cards, \$488,044 pledged, \$4031.39 average pledge

- We have six parishioners/families who are continuing to give on a scheduled basis. The total annual amount of this additional giving is \$9836.00. if we added this to the amount pledged we would have giving of \$497,880.00

- We sent out a letter on December 6th to 38 parishioners/families who have previously pledged that have not pledged this year or who have been regular donors. Since that mailing we have received 21 additional pledges from those that received letters. I continue to feel confident some of these will still make a pledge.

- On January 24th, we sent out an email letter to all parishioners/families sharing our campaign results and that we have not reached our goal. The letter thanked those who have pledged and encouraged those that have not pledged to please submit a pledge regardless of the amount. In addition, the letter offered parishioners who have submitted a pledge an opportunity to submit a supplemental pledge. Our thanks to Ellen Haase for graciously writing this letter on behalf of our Stewardship Ministry.

- We will continue to have a Stewardship messages in Tempo highlighting both Time and Treasure.

- Mtr. Suz and Jody Hunter have reviewed the list of those who have not pledged. Appropriate discernment and actions have been taken as a result of this review.

- We discussed Stewardship opportunities during Lent. During our discussion we identified the following opportunities:

- Sign-up to pray for a Ministry
- Indoor and Outdoor Workday at Holy Trinity
- Volunteers to help with Church garden

Jody Hunter will discuss the Workday at Holy Trinity opportunity with Clem Watson and help coordinate this activity if approved by the Building and Grounds Committee.

Our next Stewardship Committee meeting will be April 7th at 6:00 p.m. We will discuss potential new members for our Stewardship Ministry and begin reviewing the successes and opportunities for improvement from our 2022 Stewardship Campaign.
